### **MINUTES AND FINANCIAL REPORT**

Minutes from May meeting presented by C. Carter. A. Asbridge made a motion to accept, seconded by F. Lee; motion carried. C. Carter presented financials as prepared by A. Webb thru May 2022. Total income YTD is \$326,782 while total expenses YTD were \$291,621. J. Howell made a motion to accept; seconded A. Asbridge; motion carried.

### **MEMBERSHIP**

We had eleven (11) new applications for membership, three (3) cancellations and zero (0) terminations for the month of May. Seven (7) individuals are on medical leave. Membership receipts for May were \$39,674. Three hundred sixty-five (365) members are now on auto payment. Forty-four (44) members are on the unlimited cart plan. Current membership stands at four hundred fifty-nine (459) paying members with a total membership of four hundred seventy-five (475) members. Pool membership stand at twenty-six (26) YTD. J. Holloway made a motion to make available nine (9) more pool memberships for purchase; seconded by J. Alles, motion carried. T. Scholl made a motion to accept the membership report; seconded by J. Howell, motion carried.

### **GOLF COURSE**

B. Bradley reported that the culvert on hole #14 had been installed. A new contractor is being sought to complete the driving range project, as Paul Howard cannot commit to the job. B. Bradley suggested that Buster Cutsinger be contacted and agreed to reach out to him. Landscaping around the sign at the front entrance needs attention. The hiring of a landscaping company to complete the task will be looked into.

### **PRO SHOP**

Rounds are 7,100 YTD vs 7,300 last year. Member rounds are 6,000 YTD vs. 5,500 last year.
